Warren, Jr. and wife, Anne Douglas Warren, as tenants by the entireties with full rights of survivorship and not as tenants in common, the land lying and being situated in DeSoto County, Mississippi, described as follows, to-wit:

Lot 1, Section A, Alden Station Subdivision, located in Section 11, Township 2 South, Range 8 West, as shown on plat of said subdivision of record in Plat Book 41, Pages 43-44, in the office of the Chancery Clerk of DeSoto County, Mississippi, to which plat reference is hereby made for a more particular description of said lot.

And being the same property conveyed to Thomas Gordon Jones and wife, Imogene K. Jones by Warranty Deed of record in Book 268, Page 80, Chancery Clerk's Office, DeSoto County, Mississippi. Thomas Gordon Jones died and Imogene K. Jones conveys this property as surviving tenant by the entirety.

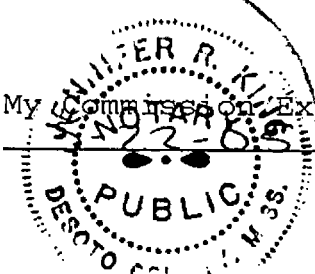
